- 4. Each entry must be between 1000-3000 words (2-5 pages), typed or print handwritten (preferably typed), double-spaced and submitted on 8 1/2" x 11" white paper. No cursive writing will be accepted.
- 5. Essay must be solely the work of the entrant. Plagiarism will result in disqualification.
- 6. Attached to each entry must be a completed contest entry form including the student's name, student's grade, teacher, guidance counselor, school name, school's address, student's address and a parent/guardian name, email address and telephone number.
- 7. Qualifying entries must reflect the contest theme.

- Clarity
- Accuracy of Their Observations and Support Resources
- Strong Conclusion
- Creativity of Assignment
- Flow of Writing
- Grammar Usage
- Free of any Grammatical, Spelling, or Punctuation Errors
